1. Container is and will remain property of All-In-Bin. Customer shall keep the Container accessible and free of any encumbrances and shall not modify the Container or use it for any purpose other than set out herein.

- 2. Customer shall use container for disposal of construction/demolition material only.
- 3. Customer agrees to bear the cost of replacement or repair of the Container resulting from improper handling or abuse by Customer's employees or agents or the use of the Container for the purposes other than for which it is designated.
- 4. For all Containers considered 'permanent'- a minimum of one pickup is required each month. After two months, All-In-Bin reserves the right to remove the bin without prior notice. Customers with a 'permanent' Container will incur service charges if Container is requested to remain on site without pick up within the month period as stated.
- 5. For all Containers considered 'temporary' a minimum of one pickup is required within a period of one week. After one week, All-In-Bin reserves the right to remove the bin without prior notice. Customers with a 'temporary' Container will incur service charges if Container is requested to remain on site without pick up within the one week period as stated.
- 6. The Customer must request container pickup by phoning the All-In-Bin dispatch 306-373-3555 or going on the website under "Schedule Bin Pick-Up". A 48 hour period between request and expected pickup is required.
- 7. Customer shall provide a suitable site for the Container and hereby guarantee All-In-Bin the right of access to the Container at all reasonable times in order to provide Service or inspection of the Container.
- 8. All-In-Bin shall not be liable for failure to perform its obligations herein if such failure is due to matters beyond its reasonable control including without limitation, compliance with any laws or bylaws, acts of God, work stoppages or delays, or the inability to obtain materials, labor, equipment or transportation.
- The Customer's failure to insist upon or enforce strict performance of any provision of these terms and conditions shall not be construed as a waiver of any provision or right. The terms and conditions contained herein are subject to change without notice.
- 10. This contract will terminate one year from date of signed container service agreement or upon agreed project completion date.
